SUBJECT: Permission to Purchase Tape Encryption Equipment Mainline Information Systems

On June 16, 2009, official action (attached) was taken to approve a contract on behalf of Information Services to purchase an IBM iSeries 8203-E4A server through Mainline Information Systems (Mainline). This server has been installed, and is in operation as the District's primary production system.

As the next step in the District's disaster recovery plan, Information Services is requesting permission to place a purchase order with Mainline for hardware, software, and engineering services to produce encrypted backup tapes. The purchase will be funded through capital outlay. Please reference the attached memo from Bruce Baldwin, Director of Information Services, and Ed Mutell, Supervisor of Information Services, for detailed information.

Mainline is IBM's recommended business partner for transactions of this nature in west central Florida. The company's services have been used by the District since 2004, and their personnel have a thorough understanding of the District's processes and procedures. We are permitted to negotiate for high-technology purchases under Florida Administrative Code Rule 6A-1.012(14). The attached quote is the result of those negotiations by the Information Services Department.

We are requesting permission to place a purchase order to Mainline in the amount of \$31,231.10. Should you have any questions or concerns, please feel free to contact Ed Mutell or me at your earliest convenience.

The new iSeries 8203-E4A has been installed, is in operation as the district's primary production system, and the IBM 820 system has been traded in for credit.

SUBJECT: Purchase Request for IBM iSeries 8203-E4A from Mainline Information Systems Inc. and Declaration of Surplus IBM 820

On June 2, 2009, official action (attached) was taken to approve a request by Information Services to negotiate with Mainline Information Systems (Mainline) for purchase of an IBM iSeries 8203-E4A. This system will replace the District's obsolete IBM 820 system.

Negotiations with Mainline (IBM's sole approved business partner for transactions of this nature) have been successful. Accordingly, we are presenting for Board approval a proposal from Mainline in the amount of \$171,405.30 to cover purchase and installation of the new equipment for Building 5. Terms and conditions for the installation services in the amount of \$8,000 (part of the purchase price) are also presented for your approval. Board approval of this transaction will allow Information Services to immediately enter a requisition for a purchase order, using capital funds. The purchase order will be issued before the close of the 2008-2009 fiscal year.

Board approval will also enable the obsolete IBM 220 system (Serial Number A01CB/BPI#8567543) to be declared surplus. The purchase price of the new equipment has been reduced significantly based on the value of recoverable software from this surplus machine. Information Services will also file paperwork directly with IBM to receive an additional \$2,500 in rebates for the surplus hardware.

The District is permitted to negotiate for high-technology purchases by Florida Administrative Code Rule 6A-1.012(14). Should you have any questions or concerns, please feel free to contact Mr. Ed Mutell, Supervisor of Information Services, or me at your earliest convenience.
