

MEMORANDUM

TO: Honorable School Board Members

RE: Second Year Renewal of Three-Year Contract
Bid #09-073-DR, Non-Food Expendable Supplies – Food and Nutrition Services
Peninsular Paper Company

On December 16, 2008, official action (attached) was taken to award the above-referenced bid to Peninsular Paper Company. This bid is a three-year contract, renewable annually based upon mutual consent of both parties. The first year of the agreement will expire on December 31, 2009.

Considering services have been satisfactory, L. B. Sierra, Bid Coordinator, Peninsular Paper Company was contacted to verify his willingness to enter into the second year of the agreement with a price increase for three items: 1) FS-067: Fortune Sheet Pan Storage Bag, current price: \$17.04, new price: \$17.86, price increase of \$.82, 2) FS-072: Fortune Bun Pan Rack Cover, current price: \$14.95, new price: \$15.76, price increase of \$.81, and 3) FS-078: Fortune Breakfast Bag, current price: \$10.29, new price: \$10.77, price increase of \$.48. The bid document states that the vendor must, at six (6) month intervals, request in-place suppliers to either extend or lower costs. If costs are increased, the supplier must solicit bids from at least two (2) approved sources. Peninsular Paper has documented (attached) that they have solicited bids for these proposed cost increases, but have not received competitive responses.

As the overall dollar increase to the bid amount is minimal (\$684.50) we believe it is in the District's best interest to renew the bid for its second year, with all other terms and conditions remaining the same. Peninsular Paper has agreed in writing (attached) to do so. The anticipated bid expenditure will be \$1,305,549.85.

Therefore, at this time, it is my recommendation to enter into the second year of the agreement with Peninsular Paper Company. The second year of the contract will cover the period of January 1, 2010 through December 31, 2009. Should you have any questions regarding this matter, or if I can be of further assistance, please feel free to contact me at your earliest convenience.

Term of Contract: This bid is for Non-Food Expendable Supplies for use throughout the District. This is the first year of a three-year bid, renewable annually by written consent of both parties. The first year of the contract will cover the period of January 1, 2009 through December 31, 2009.

Notations and Exceptions:

Recommend acceptance of bid from Peninsular Paper Company as the "lowest and best" responsive and responsible bid meeting written specifications. Prices must remain firm and fixed for six-month intervals. Cost shall remain firm through June 30, 2009. The contractor may re-solicit costs from manufacturers every six (6) months.
