RE: Second Year Renewal of Three-Year Contract
Bid #09-093-DR: USDA Commodity Chicken Processing
Asian Food Solutions, Incorporated
Out of the Shell, LLC., d/b/a Lings
Pilgrim's Pride Corporation

On February 3, 2009, official action (attached) was taken to award the above-referenced bid to Asian Food Solutions, Incorporated, Out of the Shell, LLC., d/b/a Lings, and Pilgrim's Pride Corporation. This bid is a three-year contract, renewable annually based upon mutual consent of both parties. The first year of the agreement will expire on June 30, 2010.

Considering services have been satisfactory, Lincoln Yee, President, Asian Food Solutions, Roy Meador, National Sales Administrator, Out of the Shell, LLC., d/b/a Lings and Bill Kantola, Senior Vice President Foodservice, Pilgrim's Pride Corporation was contacted to verify their willingness to enter into the second year of the agreement. As such, Lincoln Yee and Roy Meador have agreed in writing (attached), to enter into the second year of the contract. However, Roy Meador, National Sales Administrator, Out of the Shell, LLC., d/b/a Lings was not able to renew the bid due to adjustments to their Commodity program and case pack size.

USDA timeline for school districts to place orders for commodity foods and identify processing manufacturers is January 15, 2010 for the 2010/2011 school year. Due to the USDA timeline, it is necessary to renew commodity processing bids six (6) months prior to the term of the contract. Purchase orders and product orders through distributors will not be placed with awarded vendors prior to July 1, 2010. This bid in no way affect contracts already in place for the 2009-2010 school year. Because of the USDA timeline, Food and Nutrition Services is requesting permission from The Board to renew Bid #10-25-DR: USDA Commodity Peanut Butter Processing bid six months prior to term of contract.

Therefore, at this time, it is my recommendation to enter into the second year of the agreement with Asian Food Solutions, Incorporated and Pilgrim's Pride Corporation. The second year of the contract will cover the period of July 1, 2010 through June 30, 2011.



Lincoln Yee, President of Asian Food Solutions, Inc., has advised us that the reduced pricing on the following two (2) items was submitted to the Hillsborough County School District Commodity Food Processing Bid #8236-DST. Asian Foods has offered to extend the pricing under this bid to the District School Board of Pasco County.
