On April 21, 2009, official action (attached) was taken to award the above-referenced bid to Culinary Standards, JTM Provisions Co. Inc., JTM Provisions Co. Inc., Maid Rite Steak Company, Inc., Pierre Foods, Inc., and Tyson Sales & Distribution, Inc. This bid is a three-year contract, renewable annually based upon mutual consent of both parties. The first year of the agreement will expire on June 30, 2010.

Considering services have been satisfactory, Rick Kriech, President, Culinary Standards, Mike Spencer, National Sales Manager, SFS, JTM Provisions Co., Inc., Michael Bernstein, Executive Vice President, Maid-Rite Steak Company, Inc., Tony Schrader, VP of Sales, Pierre Foods, Inc., and Randall H. Collins, Division Business Manager, and Tyson Sales & Distribution, Inc. was contacted to verify their willingness to enter into the second year of the agreement. As such, they have agreed in writing (attached), to enter into the second year of the contract.

USDA timeline for school districts to place orders for commodity foods and identify processing manufacturers is January 15, 2010 for the 2010/2011 school year. Due to the USDA timeline, it is necessary to renew commodity processing bids six (6) months prior to the term of the contract. Purchase orders and product orders through distributors will not be placed with awarded vendors prior to July 1, 2010. This bid in no way affect contracts already in place for the 2009-2010 school year. Because of the USDA timeline, Food and Nutrition Services is requesting permission from the Board to renew Bid #10-26-DR: USDA Commodity Tomato Processing bid six month's prior to term of contract.

Therefore, at this time, it is my recommendation to enter into the second year of the agreement with the abovereferenced vendors. The second year of the contract will cover the period of July 1, 2010 through June 30, 2011.

Recommendation: Recommend acceptance of bids as noted on attached tabulation sheet as lowest and best responsive, responsible bids meeting written specifications.

<u>Term of Contract</u>: This bid is for the USDA Commodity Beef Processing for Food and Nutrition Services for use throughout the District and on behalf of the P.O.W.E.R. Buying Group. (P.O.W.E.R. Buying group is made up of 37 school boards.) This is the first year of a three-year bid, renewable annually by written consent of both parties. The first year of the contract is effective July 1, 2009 through June 30, 2010.

<u>Notations and Exceptions</u>: Group A: Recommend award to Pierre Foods. Pierre Foods lowest bidder to submit bid pricing for all of the products listed in Group A. As per bid document, Category A will be awarded as "all or none" to the "lowest and best" responsive and responsible total bottom line cost vendor. Group A: Pierre Foods alternate items 4A and 5A met the minimum bid specifications, were student tested, and approved.

Groups B, C, and D: Awards were made to the lowest bidder for specified products in each line item, with the following exceptions: Item 8B: recommend rejection of Advanced Food Company, Beef Chili with Beans, Reduced Fat, exceeded the fat specifications. Item 9B: recommend rejection of Advanced Food Company, Sloppy Joe, Reduced Fat, exceeded the fat specifications.

Individual School Boards are responsible for their own orders, etc.

Total savings was based on commercial prices (without processing) for the same items. The average prices were then subtracted from the commercial prices.
