On June 2, 2009, official action (attached) was taken to award the above-referenced bid to J. M. Smucker Company and Pierre Foods. This bid is a three-year contract, renewable annually based upon mutual consent of both parties. The first year of the agreement will expire on June 30, 2010.

Considering services have been satisfactory, Larry W. Herman, Vice President-Food Service, J. M. Smucker Company and Tony Schroder, Vice President of Sales, Pierre Foods, Incorporated was contacted to verify their willingness to enter into the second year of the agreement. As such, they have agreed in writing (attached), to enter into the second year of the contract.

USDA timeline for school districts to place orders for commodity foods and identify processing manufacturers is January 15, 2010 for the 2010/2011 school year. Due to the USDA timeline, it is necessary to renew commodity processing bids six (6) months prior to the term of the contract. Purchase orders and product orders through distributors will not be placed with awarded vendors prior to July 1, 2010. This bid in no way affect contracts already in place for the 2009-2010 school year. Because of the USDA timeline, Food and Nutrition Services is requesting permission from The Board to renew Bid #10-25-DR: USDA Commodity Peanut Butter Processing bid six months prior to term of contract.

Therefore, at this time, it is my recommendation to enter into the second year of the agreement with the above-referenced vendors. The second year of the contract will cover the period of July 1, 2010 through June 30, 2011.



As a result of the negotiations, it is our recommendation to award Group A to J. M. Smucker Company as the "lowest and best" responsive and responsible bid meeting written specifications. As per bid document, Category A will be awarded as an "all or none" group with the "lowest and best" responsive and responsible total bottom line cost. It is our recommendation to award Group B to Pierre Foods, Inc., as the "lowest and best" responsive and responsible bid meeting written specifications for that group.

This bid is for use District use and was solicited on behalf of the P.O.W.E.R. Buying Group. The P.O.W.E.R.
