**Clinical Experiences
AGREEMENT**

This agreement, made and entered into by and between **UNIVERSITY COMMUNITY HOSPITAL, INC.**, UCH Medical Center, 3100 E. Fletcher Avenue, Tampa, Florida 33613-4688 and UCH Carrollwood, 7171 N. Dale Mabry Highway, Tampa, Florida 33614-2670, and University Community Long Term Acute Care at Connerton, 9441 Health Center Drive, Land O'Lakes, FL 34637, (collectively referred to as "UCH") and the District School Board of Pasco County, for the benefit of its students for December 16, 2008.

WITNESSETH

WHEREAS, wishes to use **UCH** facilities to implement its Health Occupations Program and Students at the **District School Board of Pasco County**.

WHEREAS, **UCH** wishes to assist in implementing its Health Occupations Students ("Program") by permitting the **District School Board of Pasco County** faculty and students to use UCH facilities for clinical experiences, and NOW THEREFORE, in consideration of the mutual covenants herein, the parties agree as follows:

I. UCH SHALL:

1. Provide opportunities for observational and practical experiences in the patient units and clinics and in other **UCH** departments, as determined by **UCH** in consultation with the **District School Board of Pasco County**.
2. Provide adequate classroom and conference room space and library facilities and materials for instructional and clinical learning experiences, when not in use by **UCH**, and subject to this agreement.
3. Provide faculty and students with medical care in case of illness or injuries incurred while on duty. Any treatment received by faculty or students as a result of illness or injury will be billed to and paid by the faculty member or student or insurers.
4. Retain overall responsibility for quality of patient care at all times.
5. Provide orientation of the **UCH** facilities, policies and procedures to students and faculty. District School Board

6. Permit students and faculty to use **UCH** cafeteria and deli facilities at their own expense. JAN 20 2009

7. Indemnify and hold harmless the **District School Board of Pasco County**, its faculty, staff, officers, trustees, students, affiliates and their respective agents, from any and all liability, claims, lawsuits, judgments and expenses arising out of any act or omission on the part of any **UCH** employee, agent, or independent contractors, to the extent specifically authorized by Florida Statute 768.28.

II. THE SCHOOL SHALL:

1. Select patient assignments in cooperation with UCH staff.
2. Provide concurrent related instruction, supervision and guidance as required to meet program objectives.
3. Maintain individual student records of class and work instruction, evaluations of student competencies and health status reports.
4. Provide professional liability insurance for the **District School Board of Pasco County**, faculty and students in the amount of one million dollars (\$1,000,000) for any one occurrence and a minimum of three million dollars (\$3,000,000) in the aggregate.
5. Require that all students assume financial responsibility and maintain health insurance for personal illness, injuries, and accidents at UCH, including without limitation, all injuries that may occur as a result of services performed under this Agreement, regardless of fault, and shall indemnify and hold UCH harmless from and against all such injuries and accidents and shall immediately upon demand reimburse UCH for the cost of treating all such accidents and injuries.
6. Assure that all faculty and students comply with UCH policies and procedures.
7. Indemnify and hold harmless UCH from any and all liability, claims, lawsuits, judgements and expenses arising out of any act or omission on the part of any student or faculty of the **District School Board of Pasco County**.

III. WITHDRAWAL OF STUDENT OR FACULTY:

1. UCH has the right to request the **District School Board of Pasco County** to withdraw any student or faculty member from its facilities whose conduct or work with patients or personnel is not, in the opinion of UCH administrators, in accordance with acceptable standards of performance.
2. **The District School Board of Pasco County** has the right to withdraw a student whose performance or conduct does not meet Program standards.

IV. REVIEW, REVISION, AND TERMINATION

Board Approved

1. The terms of this agreement shall remain in effect for one (1) year from the date of signature and school board approval, and therefore will automatically renew for one (1) year terms until otherwise terminated by either party, but shall not exceed three (3) years from the date first written above.
2. Modification of this agreement shall be made upon mutual consent of the parties by addendum or amendment attached to this agreement.

- 3. Either party may terminate this agreement upon thirty days written notice to the other party.

V. THE PARTIES FURTHER AGREE THAT:

- 1. Nothing in this agreement shall be construed as creating an agency, employment or joint venture relationship between UCH and The District School Board of Pasco County. UCH shall provide no compensation to faculty and students for services rendered to UCH through the program clinical experiences.
- 2. The assignment of students and faculty will be made without regard to the race, creed, color, sex, veteran status, sexual orientation, or national origin.
