USDA Commodity Peanut Butter Processing

On May 19, 2009, we requested Board approval to directly negotiate USDA Commodity Peanut Butter Processing. The request was a result of both vendors returning submittals that had not been correctly calculated based on a pre-determined formula.

After the Board's approval to negotiate, we contacted both Pierre Foods, Inc. and J. M. Smucker Company, to explain the direct negotiation process. As a result of the negotiations, it is our recommendation to award Group A to J. M. Smucker Company as the "lowest and best" responsive and responsible bid meeting written specifications. As per bid document, Category A will be awarded as an "all or none" group with the "lowest and best" responsive and responsible total bottom line cost. It is our recommendation to award Group B to Pierre Foods, Inc., as the "lowest and best" responsive and responsible bid meeting written specifications for that group.

This bid is for use District use and was solicited on behalf of the P.O.W.E.R. Buying Group. The P.O.W.E.R. Buying Group is made up of the following 37 school boards: Bay County, Brevard County, Calhoun County, Charlotte County, Citrus County, Collier County, Desoto County, Flagler County, Franklin County, Glades County, Hardee County, Hendry County, Hernando County, Highlands County, Indian River County, Jackson County, Lake County, Liberty County, Lee County, Leon County, Levy County, Marion County, Miami-Dade County, Monroe County, Nassau County, Okaloosa County, Okeechobee County, Osceola County, Pasco County, Santa Rosa County, Seminole County, St. Johns County, St. Lucie County, Sumter County, Volusia County, and Washington County. Individual School Boards are responsible for their own orders, etc.

This will be the first year of a three-year bid that is renewable annually by written mutual consent and approval by The Board. The first year of the contract will commence on July 1, 2009 and continue through June 30, 2010. Estimated total for this bid for our District is \$335,000 and will be purchased utilizing Special Revenue Funds. Estimated annual savings for our District through this bid is \$13,400. Total savings was based on averaging the current commodity and commercial prices, and then deducting awarded bid.
