On April 21, 2009, official action (attached) was taken to award the above-referenced bid to Culinary Standards, JTM Provisions Company Incorporated, Maid Rite Steak Company, Incorporated, Pierre Foods, Incorporated, and Tyson Sales & Distribution, Incorporated. This bid is a three-year contract, renewable annually based upon mutual consent of both parties. Subsequently, the second year of the agreement was awarded on December 15, 2009. The second year of the agreement will expire on June 30, 2011.

Considering services have been satisfactory, Chris Burnham, Vice President General Manager, Culinary Standards, Mike Spencer, National Sales Manager, SFS, JTM Provisions Company, Incorporated, Michael Bernstein, Executive Vice President, Maid-Rite Steak Company, Incorporated, Michael S. Turley, Vice President of Sales, AdvancePierre Foods (Formerly DBA: Pierre Foods, Inc.), and Randall H. Collins, Division Business Manager, and Tyson Sales & Distribution, Inc. was contacted to verify their willingness to enter into the third year of the agreement. As such, Mike Spencer, Michael Bernstein, and Michael S. Turley have agreed in writing (attached), to enter into the third year of the contract. However, Chris Burnham, Vice President General Manager, Culinary Standards, is not willing to renew for the third year due to manufacturer price increase.

USDA timeline for school districts to place orders for commodity foods and identify processing manufacturers is several months before the beginning of the 2011/2012 school year. Due to the USDA timeline, it is necessary to renew commodity processing bids several months prior to the term of the contract. Purchase orders and product orders through distributors will not be placed with awarded vendors prior to July 1, 2011. This bid in no way affects contracts already in place for the 2010-2011 school year. Because of the USDA timeline, Food and Nutrition Services is requesting permission from The Board to renew Bid #09-094-DR: USDA Commodity Beef Processing bid three months prior to term of contract.

Therefore, at this time, it is my recommendation to enter into the third year of the agreement with JTM Provisions Company Incorporated, Maid Rite Steak Company, Incorporated, AdvancePierre Foods, and Tyson Sales & Distribution, Incorporated. The third year of the contract will cover the period of July 1, 2011 through June 30, 2012.

Term of Contract: This bid is for the USDA Commodity Beef Processing for Food and Nutrition Services for use throughout the District and on behalf of the P.O.W.E.R. Buying Group. (P.O.W.E.R. Buying group is made up of 37 school boards.) This is the first year of a three-year bid, renewable annually by written consent of both parties. The first year of the contract is effective July 1, 2009 through June 30, 2010.

Notations and Exceptions: Group A: Recommend award to Pierre Foods. Pierre Foods lowest bidder to submit bid pricing for all of the products listed in Group A.
