Recommendation:

Recommend acceptance of bids as noted on the attached tabulation sheet as lowest and best, responsive, responsible bids meeting written specifications.

Term of Contract:

This bid is to establish a firm fixed price for the annual purchase of paper products to be stocked in the central warehouse for use throughout the District.

Notations and Exceptions:

In most cases, paper was bid in two groups per category recycled content and non-recycled. (i.e., Group I Drawing Paper – Non-Recycled and Group I-A Drawing paper – Recycled content). Any group denoted with an “A” after the group refers to a recycled content product. Bidders were advised only one group would be awarded based upon costs.

Offers from the vendors listed herein are the only offers received timely as of the specified opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.

Group I Drawing Paper- Recommend acceptance of bid from Pyramid School Products as the lowest and best, responsive and responsible bid meeting written specification and testing criteria. Recommend rejection of bids from Ace Office Supplies, AFP Industries, Bye-Mo’r Inc., and DGS Educational as the samples were too thin and markers bled through the paper.

Group IV Practice Paper, Chart Paper, and Newsprint Paper

PP-09 Practice Paper, PP-16 Newsprint Paper, PP-57 Storybook Newsprint-Recommend rejection of all bids for Group PP-09, PP-16, PP-57 as the same product was bid for recycled content under IVA for the same cost as the virgin product and met minimum specified recycled content.

Group IVA Practice Paper, Chart Paper, and Newsprint Paper

PP-09A Practice Paper, PP-16A Newsprint Paper, PP-57A Storybook Newsprint-Recommend acceptance of bid from AFP Industries as the lowest and best, responsive and responsible bid meeting written specifications, testing criteria and specified recycled content.

Group V Railroad Board- Recommend acceptance of bid from DGS Educational as the lowest and best, responsive and responsible bid meeting written specifications and testing criteria.

Group VA Railroad Board- Recommend rejection of all bids for Group VA as the same product was bid for virgin paper under V for the same cost. The assorted railroad board met the recycle content but the white railroad did not meet the minimum specified recycled content.

Group VII Envelopes

PP-26 10" x 15" Clasp Envelopes- Recommend acceptance of bid from Pyramid School Products as the lowest and best, responsive and responsible bid meeting written specification and testing criteria. Recommend rejection of bid from DGS Educational as the envelope was 10 x 13 and did not meet the specifications.

P-32 # 10 envelopes- Recommend acceptance of bid from Pyramid School Products as the lowest and best, responsive and responsible bid meeting written specification and testing criteria. Lower bid from Bye-Mo'r was disqualified as they did not submit the requested sample used for testing and evaluation purposes.

PP-67 12" x 15" envelopes- Recommend acceptance of bid from School Specialty as the lowest and best, responsive and responsible bid meeting written specification and testing criteria. Lower bid from Bye-Mo'r was disqualified as they did not submit the requested sample used for testing and evaluation purposes.

Group X Misc. Paper Products

PP-44 Continuous Pin Feed- Bid from Standard Stationary was disqualified as they did not submit the requested sample used for testing and evaluation purposes. Request permission to purchase using competitive quotes.

Group XI Construction Paper- Recommend acceptance of bid from Ace Office Supplies as the lowest and best, responsive and responsible bid meeting written specification and testing criteria.

Group XIA Construction Paper- Recommend rejection of all bids for Group XIA. Recommend rejection of the low bid from AFP Industries as the samples were dull, thin, and had poor texture.
