Request Permission to Piggyback School District of Hillsborough County

RFP 8221-DST, Telecom Services (E-Rate), awarded to Paetec

The District School Board of Pasco County uses twelve (12) telephone lines, call PRI lines, to provide dial-tone to our telephone system across all District properties in our three (3) area codes. These lines are provided by Paetec, piggybacking the above-referenced RFP from Hillsborough Schools. The current contract term expires June 30, 2011.

The Information Services Department is recommending that the District continue to piggyback this RFP, for the term July 1, 2011 – June 30, 2012. Please see the attached memo from Mr. Chris Jackson, Supervisor of Information Services, for detailed information. Paetec has agreed in writing (attached) to extend to the District all the terms, conditions and pricing of the Hillsborough Schools RFP.

The monthly cost for this service is paid as a utility. The cost for the upcoming term will be \$55,211.04, with the District filing for E-Rate reimbursement for the funds. The District is permitted to piggyback this RFP under DOE Rule 6A-1.012(6).

The District School Board of Pasco County currently uses twelve Paetec lines to provide dialtone to our telephone system across all schools in all three of Pasco County's area codes. Information Services is recommending that the District School Board of Pasco County continue to piggyback the Hillsborough Schools RFP for PRI service from Paetec. The cost for these services for the period July 1, 2011 - June 30, 2012 will be \$55,211.04. Funding will be provided using the existing utility budget procedure. We plan to file for e-rate reimbursement for these connections. There is not an adverse risk to the District since we are not planning to terminate early and the commitment is based on an annual contract.
