Recommendation: Recommend acceptance of bids as noted on the attached tabulation sheet as lowest and best, responsive and responsible bids meeting written specifications.

Term of Contract: This is an annual purchase for office products to be stocked in the central warehouse for use throughout the District.

Notations and Exceptions: Recommend acceptance of all lower bids as meeting the written specifications and testing criteria as specified in the bid documents with the following exceptions:

OS-006: Recommend acceptance of bid from Quill Corporation as the lowest and best, responsive and responsible bid meeting written specifications. Recommend rejection of lower bids from AFP Industries, Inc. and Business Stationers for the tape dispensers as they had a loose core and dull tape cutter.

OS-007: Recommend acceptance of bid from School Specialty as the lowest and best, responsive and responsible bid meeting written specifications. Recommend rejection of lower bids from Quill Corporation, AFP Industries, Inc., Bye-Mo'r, Inc., Elgin School Supply, Pyramid, and Standard Stationery as the metal arm on the file folders bends easily.

OS-011: Recommend acceptance of bid from Pyramid School Products as the lowest and best, responsive and responsible bid meeting written specifications. Recommend rejection of lower bid from Standard Stationery as the pocket portfolios were very thin and ripped easily.

OS-012: Recommend acceptance of bid from Quill Corporation as the lowest and best, responsive and responsible bid meeting written specifications. Recommend rejection of lower bid from Bye-Mo'r, Inc. as the rubber bands had poor elasticity.

OS-018: Recommend acceptance of bid from DGS Educational Products as the lowest and best, responsive and responsible bid meeting written specifications. Recommend rejection of lower bid from Standard Stationery Supply Co. as the staples fit tight and hard to open. Recommend rejection of lower bids from Pyramid School Products and Smith Office & Computer Supply as the staples were hard to staple and fit tight.

Notations and Exceptions:

OS-020: Recommend acceptance of bid from Pyramid School Products as the lowest and best, responsive and responsible bid meeting written specifications. Recommend rejection of lower bid from Standard Stationery as vendor bid multiple items and bid document specified one bid and one alternate only would be considered. If bidder listed more than specified it would result in automatic disqualification for that item.

OS-23 through 27: Recommend acceptance of "all or none" bid from School Specialty as lowest and best, responsive, responsible bid meeting written specifications. Recommend rejection of lower bids from Bye Mo'r, Inc. and Smith Office Supply Company; did not bid all items required. Standard Stationery as vendor bid multiple items and bid document specified one bid and one alternate only would be considered. If bidder listed more than specified it would result in automatic disqualification for that item.

OS 029: No bids were received for this item. Request permission to purchase on the open market after revising specifications and obtaining quotes.

OS-035: Recommend acceptance of bid from Bye-Mo'r, Inc. as the lowest and best, responsive and responsible bid meeting written specifications. Recommend rejection of lower bid from Standard Stationery as the binder bends too easily.
