Laser Printer Cost Per Copy

On August 18, 2009 official action (attached) was taken to renew the Laser Printer cost-per-copy agreement Contract # 914-000-05-R with RESPECT of Florida/Abilities of Florida through July 6, 2010.

The State of Florida is recommending award of a new 5-year contract 05-914-000-N with RESPECT of Florida (see attached). RESPECT of Florida is in partnership with Florida's state and local government agencies and provides employment opportunities to Florida residents with disabilities in accordance with Section 413.036 Florida Statutes. In addition, under Florida Statue, Chapter 287.056 purchases can be made for services from state term contracts.

RESPECT of Florida and the technicians from Abilities of Florida will continue to work together to maintain their current employees with disabilities as well as to train and employ additional persons with disabilities for their contract. The cost per copy for services under the contract with RESPECT of Florida will continue to be \$.008990. This cost per copy has remained the same since 2005.

At this time, it is the recommendation of the Information Services Department to enter into a one-year agreement with RESPECT of Florida pending final approval of their bid on July 7, 2010. The contract will cover July 7, 2010 through July 6, 2011. Based upon the cost analysis by the information Services Department, it is estimated that total expenditures for this one-year period will be approximately \$310,000.

Pursuant to Section 3.4 of the RFP No. 05-914-000-N, the Department of Management Services intends to award to RESPECT of Florida to provide services as a Central Non-Profit Agency representing employment centers for the blind or other severely handicapped.
