Coca-Cola Enterprises Price Changes

On July 28, 2009, official action was taken to award the first year of the above-referenced Request for Proposal to Coca-Cola Enterprises and renewed for the second year on May 4, 2010.

Coca-Cola has requested to rollback the vend price for student-access vending machines in high schools. The \$1.25 vend price will be reduced to \$1.00 for all 20 ounce diet sparkling brands (Coke Zero, Diet Coke, Cherry Coke Zero, Sprite Zero, Fanta Orange Zero, and Vault Zero) and 20 ounce Dasani bottled water. Price conversions will be completed by September 30, 2010.

Rick Kurtz, Director of Food and Nutrition Services, recommends approval of the provisions stated above considering services have been satisfactory and students will have the ability to purchase from vending machine selected 20 ounce Coca-Cola beverages at a reduced price.

Coca-Cola has made a decision to rollback the vend price for high school student-access vending machines for school year 2010-2011. The \$1.25 vend price for all 20 ounce Diet Sparkling brands (Coke Zero, Diet Coke, Sprite Zero, Fanta Orange Zero, Cherry Coke Zero, and Vault Zero) and 20 ounce Dasani bottled water will be reduced to \$1.00. The conversion will be completed by September 30, 2010.

The decision was based on the current economic situation and the need to make it more affordable for the students. All commission rates in Section 3C of RFP#10-019-DE Exclusive Beverage Contract will remain unchanged. Additionally, the vend prices for the following packages below will remain unchanged:

- All 12 ounce cans
- 10 oz Minute Maid juices
- 12 ounce Fuze
- 12 ounce and 20 ounce Powerade
- 300ml Dasani bottled water
- 12 ounce and 20 ounce Vitaminwater
- 16 ounce Energy

When: conversion to begin July/August 2010


**How:** Coca-Cola vending operations team will strategically schedule and complete conversions by the end of September 2010.










