Requesting Three (3) Month Bid Extension

On September 2, 2008 official action was taken to award the above-referenced bid to Superior Sheds, Inc. (see attached). This bid is a three-year contract, renewable annually, based upon mutual consent of both parties. The second-year of the agreement will expire on September 2, 2010.

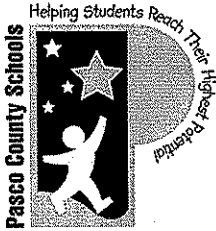

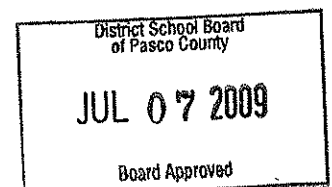
RE: Bid # 09-038-AF, Purchase and Installation of Storage Sheds

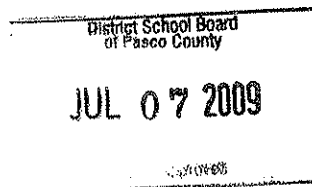




