Amendment to

School Readiness Provider Payment Agreement

2010-2011



The School Readiness Provider Payment Agreement (hereinafter known as "Agreement") is being amended effective July 29, 2010, notwithstanding signature dates.

The Agreement section being amended (page 9, P. 3.) currently requires:

The PROVIDER understands that any program found below 80% compliance with the terms of this Agreement will be required to submit a Corrective Action Plan and will receive a follow up evaluation within thirty (30) days. Corrective Action Plans will be monitored by the COALITION and failure to comply may result in termination of this Agreement, therefore disallowing continued disbursement of School Readiness funds. Refer to Program Monitoring Procedure for additional information regarding compliance with program assessments.

Amended section now requires:

The PROVIDER understands that any program found below 85% compliance with the School Readiness Program Assessment (SRPA) will be required to submit a Corrective Action Plan (CAP) and will receive a follow up SRPA within thirty (30) days. CAPs will be monitored by the COALITION and failure to comply may result in termination of this Agreement, therefore disallowing continued disbursement of School Readiness funds. Refer to Program Monitoring Procedure for additional information regarding compliance with the SRPA.

All provisions in the Agreement not in conflict with this amendment are still in effect, and are to be performed to the same level as specified in the Agreement.

This Amendment is hereby made a part of the Agreement.
