Notations and Exceptions:

This bid/RFP was awarded upon a weighted points system. The weighted point criteria were based upon the following weights: Quality (9); Base Price (6), and References (9). Points were assigned on a scale of 1 to 5 in each of the above entries, then multiplied by the weighted points factor.

Although Jostens received the highest number of points, after further review of the bid documents by the school board attorney, Jostens proposal was disqualified due to non-compliance of required submittals (identifying which rings were being proposed in the pamphlet/brochure with the original submittal).
