Requesting Permission to Piggy-back the Suwannee County Public Schools

RFP #04-206 for Modular Classrooms/Buildings

Mobile Modular

Under the Department of Education Rule 6A-1.012(6), the Board may make purchases from contracts awarded by other District School Boards, when the awarded vendor allows it with the same terms and conditions, and such purchases are to the economic advantage of the District School Board. Considering a competitive process was conducted through the Suwannee County Public Schools that resulted in an award for modular buildings and the successful vendor, Mobile Modular has agreed in writing to extend this RFP, it is my recommendation to "piggy-back" the Suwannee County Public Schools Bid #04-206.

At this time, we are requesting permission to use the Suwannee County Public Schools RFP for a blanket amount not to exceed \$450,000 for the purchase of three (3) modular buildings to be utilized as employee health centers. As per our direct negotiated contract with the employee health care provider, CareHere, they will be contributing \$50,000 per modular for a total of \$150,000 towards the costs. The balance of funding will be from Capital funding.
