Notations and Exceptions:

Recommend rejection of lower priced bid from DeMoulin. The green color in the sample uniform and green color swatch submitted did not match the existing school color fabric (previous band uniform) as specified in the bid document. The colors must be identical matches as the band director will need to use previous band uniform pieces for substitutes when uniforms in use are being repaired.

Offers from the vendors listed herein are the only offers received timely as of the above opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.


