Recommendation: Recommend acceptance of bid as noted on attached bid tabulation as lowest and best, responsive and responsible bid meeting written specifications.

Term of Contract: This bid is to establish firm fixed prices for the purchase of Large Kitchen Equipment for the Food and Nutrition Service Department. This is a three-year bid, renewable annually by mutual consent of both parties. This is the first year of a three-year contract effective April 18, 2012 through March 27, 2013.

Notations and Exceptions: Recommend rejection of bid from Curran Taylor, Incorporated for not bidding on item numbers 13, 14, 17, 21 through 24, 25 through 34, and 39 through 42. As outlined in bid document, this is an "All-or-None" bid. Recommend acceptance of bid from Beltram Edge Tool Supply, Incorporated as lowest and best, responsive and responsible bid meeting written specifications.

Total savings were determined by averaging all prices and deducting awarded bid.

Offers from the vendors listed herein are the only offers received timely as of the specified opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
