This letter is intended to notify you that as of June 3, 2011, Central Carting Disposal, Inc., and, CCI Hauling, Inc. transferred, sold, assigned, and conveyed all of its assets to Choice Environmental Services, Inc.

You should also be aware that Choice is owned by Swisher Hygiene Inc. Swisher is a publicly traded company listed on the NASDAQ and the Toronto Stock Exchanges (NSADAQ:SWSH, TSX: SWI), and benefits from the involvement of waste industry legend, H. Wayne Huizenga and Steve Berrard.

ASSIGNMENT AND ASSUMPTION AGREEMENT

This AGREEMENT made and effective as of the 2 day of June, 2011, by and between Central Carting Disposal, Inc. ("Central") and Choice Environmental Services, Inc. ("Choice").

WHEREAS, as part of the sale of certain assets pursuant to a certain Asset Purchase Agreement dated June 3, 2011 between them among others, Central and Choice are desirous of Central assigning all of its right, title and interest in and to the certain agreement(s) as set forth on Exhibit "A" attached hereto and made a part hereof, to Choice, subject to the approval of said assignment(s) by the other parties to the agreement(s) set forth on Exhibit A where required. Choice is to assume all of Central's duties and obligations relating to future performance of the agreement(s).

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, for other good and valuable consideration, the receipt of which is hereby acknowledged, and intending to be legally bound, the parties hereto agree as follows:

- 1. Central hereby assigns and transfers to Choice all of its rights, title and interest in and to the agreement(s) set forth on Exhibit A.
- 2. Choice hereby assumes all duties and obligations of Central, relating to future performance under the agreement(s) set forth on Exhibit A and agrees to discharge and perform such duties and obligations.
- 3. This Assignment and Assumption Agreement shall be binding upon the parties, and their respective heirs, successors and permitted assigns.
- 4. Central and Choice understand and acknowledge that the assignment(s) contemplated by this Assignment and Assumption Agreement is of no force and effect unless and until the assignment(s) of the agreement(s) set forth on Exhibit A is/are approved and authorized by the other parties to the agreement(s), if and where required.
- 5. It is the intent of the parties hereto that all questions with respect to the construction of this Agreement and the rights and liabilities of Central and Choice hereunder shall be determined in accordance with the laws of the State of Florida, without regard to principles of conflicts of laws thereof that would call for the application of the substantive law of any jurisdiction other than the State of Florida.
- 6. This Agreement may be executed in multiple executed counterparts, each of which will be deemed an original and will bind the signatory, but all of which together will constitute but one and the same instrument. A signed copy of this Agreement delivered by facsimile, email or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.
