Term of Contract: This proposal is for the purchase of Caps & Gowns, Rings and Announcements for Sunlake High School. This is a three-year contract, renewable annually based upon the mutual consent of both parties. The first year will commence on October 22, 2008 and continue through October 21, 2009.

Notations and Exceptions: This RFP was awarded upon a weighted points system. The weighted point criteria were based upon the following weights: Quality (15), Base Price (5), and References (10). Points were assigned on a scale of one (1) to five (5) in each of the above entries, and then multiplied by the weighted point factor.

Although only one bid was received, prices have been deemed competitive based on a comparison of previous bids for caps and gowns, rings and announcements awarded by the District.

The estimated total of the bid was calculated by multiplying the average cost for each section by the estimated number of student that will be purchasing the items.

Offers from vendors listed herein are the only offers received timely as of the above opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
