Three (3) month Extension Request

September 5, 2011 through December 4, 2011

Able Body Labor (Extending), Express Personnel Services (Not Extending – Non-Response), Labor Finders (Not Extending) Labor Ready (Extending), Maxim Healthcare (Extending), and Suwannee Medical (Extending).

On September 5, 2006, official action (attached) was taken to award the Temporary Personnel Services bid to the above-referenced vendors. This bid is a five-year contract, renewable annually based upon mutual consent of the parties. The fifth year of the agreement will expire on September 4, 2011.

Considering services have been satisfactory, all companies were contacted to determine their willingness to enter into an extension to this bid. As such, all parties agreed to the extension with the exception of Labor Finders who have chosen not to extend. Several attempts have been made to contact Express Personnel Services and have all been unsuccessful which included a certified letter, therefore, we are not requesting the extension with Express Personnel Services.

The terms and conditions of the bid allow for price adjustments at the annual renewal based upon the change in the Producer Price Index (PPT) published by the Bureau of Statistics, U.S. Department of Labor, using Series ID # PCU56143805613801, Not Seasonally Adjusted, Industry: Staffing services (except PEOs) Product: Temporary help services. An increased price adjustment of 1.04 was requested by all vendors willing to enter into the extension and is in accordance with the PPI published allowance. Florida's minimum wage also increased \$.06/hour effective June 1, 2011. Florida's minimum wage is now \$7.31/hour. Per the terms of the original bid, the companies are permitted to increase their labor rates to reflect the new minimum wage rates.

Recommendation:

Recommend acceptance of bids as noted on attached bid tabulation sheet as lowest and best responsive, responsible bids meeting written specifications. In addition, we are requesting permission to negotiate with interested parties for Category IV, as we only received one bid. Due to the high demand for these services, the using department has requested two additional vendors be selected.

Term of Contract:

This bid is a multi-awarded bid by category. This is the first year of a five-year bid, renewable annually by written mutual consent. The first year of the contract will commence September 5, 2006 and continue through September 4, 2007.

Notations and Exceptions:

The award of this bid is by multiple award for the three most responsive, responsible bidders in each category meeting written specifications. Under the terms of the bid, when requesting temporary services, the District may request placement from any one of the three awardees.

Recommend rejection of Able Body Labor for Job Category I for not meeting the written specification that all jobs in each category must be bid. Recommend rejection of Suwannee Medical Personnel for Job Categories I and III for not meeting the written specification that all jobs in each category must be bid.

Unit cost remain the same, fixed service fees may be increase based upon School Board approval and at anytime during the duration of this contract with 30 days written notice. Total will vary depending on actual needs.
