On July 5, 2011, official action was taken to award the above-referenced bid to Red Gold, LLC. on an "all-or-none" basis for USDA Commodity Tomato Processing. The current bid language allows for new items to be added to the bid by awarded vendors as they become available.

Red Gold, LLC. has submitted pricing for four (4) new additional tomato products: (1) Sauce, marinara, Vitamin Enhanced, (2) Sauce, Pizza, Vitamin Enhanced, (3) Ketchup, Jalapeno Flavored, and (4) Red Gold Salsa 80.2 ounce Dipping Cup. Please refer to the fee for service and net off invoice price information (attached) for the sandwich products to be effective through June 30, 2012. Adding these items will allow us to better utilize our USDA entitlement monies. Pricing on these products are at or below retail prices and found to be competitive.

Estimated annual purchases are not anticipated to change the total bid award of \$160,000, utilizing Special Revenue Funds. It is my recommendation that these products be added to our USDA Commodity Tomato Processing bid.
