**Addendum Contract Terms and Conditions to Cooperative Agreement**

The District School Board of Pasco County (Hereinafter referred to as "School") and New Port Richey Facility Operations, LLC (called Consulate Health Care in the original contract), 8417 Old County Road 54, New Port Richey, FL 34653 (Hereinafter referred to as "Facility") hereby agree that the provisions below will be added and incorporated to the Cooperative Agreement, effective January 1, 2011 (the "Agreement"). This Addendum shall be attached thereto. If any of the provisions in the Addendum conflict with any of the provisions in the Agreement, the Addendum will control and trump the provisions in the Agreement.

**The following provisions are hereby added to Section V of the Agreement:**

- "6. The Facility retains the unilateral right to accept, reject, or terminate students in the program at its sole discretion.
- 7. The Facility retains the right to require students enrolled in the program to enter into agreements necessary to protect the protected health information and privacy of its residents."
