RE: Third Year Renewal of Three-Year Contract
Bid #11-085-DR: USDA Commodity Tomato Paste (Tote) Processing
Red Gold, LLC

On July 5, 2011, official action (attached) was taken to award the above-referenced bid to Red Gold, LLC. This bid is a three-year contract, renewable annually based upon mutual consent of both parties. Subsequently, the second year of the contract was awarded on December 6, 2011. The second year of the contract will expire on June 30, 2013.

Considering services have been satisfactory, David Halt, Foodservice Director, Red Gold, LLC, was contacted to verify his willingness to enter into the third year of the agreement. As such, David Halt has agreed in writing (attached), to enter into the third year of the contract with a price increase of 1.034 Weighted Index. The increase is based on the monthly Producer Price Indexes published by the Bureau of Statistics, U.S. Department of Labor using 50% weighting from Industry Data Series ID: #PCU48412-48412-, and 50% weighting from Industry Data Series ID: #PCU311---311---, using the month of May, final version. The annual percentage change in the Producer Price Index is based on the May, 2012 index for the third contract year, as stated in the bid document.

Due to the USDA timeline, it is necessary to renew commodity processing bids six (6) months prior to the term of the contract. Purchase orders and product orders through distributors will not be placed with awarded vendors prior to July 1, 2013. This bid in no way affects contracts already in place for the 2012/2013 school year. Because of the USDA timeline, Food and Nutrition Services is requesting permission from the Board to renew Bid #11-085-DR: USDA Commodity Tomato Paste (Tote) Processing five months prior to term of contract.

Therefore, at this time, it is my recommendation to enter into the third year of the agreement with Red Gold, LLC. The third year of the contract will cover the period of July 1, 2013 through June 30, 2014. On July 5, 2011, official action was taken to award the above-referenced bid to Red Gold, LLC. on an "all-or-none" basis for USDA Commodity Tomato Processing. The current bid language allows for new items to be added to the bid by awarded vendors as they become available.

Red Gold, LLC. has submitted pricing for four (4) new additional tomato products: (1) Sauce, marinara, Vitamin Enhanced, (2) Sauce, Pizza, Vitamin Enhanced, (3) Ketchup, Jalapeno Flavored, and (4) Red Gold Salsa 80.2 ounce Dipping Cup. Please refer to the fee for service and net off invoice price information (attached) for the sandwich products to be effective through June 30, 2012. Adding these items will allow us to better utilize our USDA entitlement monies. Pricing on these products are at or below retail prices and found to be competitive.

Estimated annual purchases are not anticipated to change the total bid award of \$160,000, utilizing Special Revenue Funds. It is my recommendation that these products be added to our USDA Commodity Tomato Processing bid.
