Renewal of Direct Negotiated Contract

Envision Pharmaceutical Services, Inc. for Pharmacy Benefit Management

On November 1, 2011, the Board gave approval for a contract with Envision Pharmaceutical Services (Envision) to provide pharmacy benefit management services for Pasco School Board employees. This is a three (3)-year contract; the first year term will expire on December 31, 2012. The contract is on file in the Purchasing Department.

Please see the attached memo from Mary Tillman, Director of Employee Benefits and Risk Management, for detailed information regarding the significant benefits and cost savings this contract brings to the District. At Ms. Tillman's request, Purchasing has contacted Envision to verify their willingness to enter into the second year of the contract. Envision has agreed in writing (attached) to do so.

The District is permitted to negotiate for services of this nature under Florida Administrative Code 6A-1.012(15). We are requesting Board approval of the contract renewal for its second year, January 1, 2013 – December 31, 2013. RE:

Renewal of Pharmacy Benefit Manager - Envision

On November 1, 2011, the Board gave approval for a contract with Envision to provide pharmacy benefit management services for Pasco School Board employees. This is a three-year contract; the first year term will expire on December 31, 2012.

Based on analysis made by consultants from MedVision and Crowne Consulting, and reviewed by EBARM staff and the Finance Subcommittee, it appears that the District will see significant savings under the "pass-through" style contract offered by Envision.

After almost a full year of operations, the District has seen significant savings using Envision. We anticipate a total savings in the pharmacy plan in excess of \$1 million for the 2012 calendar year.

At this time, I am requesting your assistance in obtaining the Board's approval of the second year term of the contract with Envision for the term January 1, 2013 through December 31, 2013. As always I appreciate your assistance and that of your staff during this process.

Pharmacy Benefit Manager Contract

Envision Pharmaceutical Services, Inc.,

On October 4, 2011, The Board granted permission to Employee Benefits Staff (EBARM) and the Finance Subcommittee to negotiation with Envision Pharmaceutical Services, Inc. (Envision), to provide pharmacy benefit management services for District School Board of Pasco County employees.

EBARM and District consultants form MedVision and Crowne Consulting have negotiated the attached contract with Envision and are recommending The Board approve said contract as submitted. The term of this contract will be for three years starting on January 1, 2012 renewable annually by mutual consent of both parties. The terms and conditions have been approved by Nancy Alfonso, Board Attorney. The District is permitted to negotiate for services of this nature under Florida Administrative Code 6A.012(15).

It is estimated that the costs to the District for this service will be \$12,000,000 and will generate significant savings under the "pass-through" style contract offered by Envision.
