On August 2, 2011, official action was taken to award the above-referenced bid to Blue Bell Creameries, L.P. Subsequently, the second year of the agreement was awarded on July 3, 2012. The second year of the agreement will expire on August 18, 2013.

Under the terms and conditions of the bid, as new products become available they may be added to the contract. John Neal Robinson, Sales Manager, Blue Bell Creameries, L.P., has submitted pricing for two (2) new lower-fat ice cream products. These products will replace two (2) items being discontinued and are available at the same cost. In addition, the ice cream products are in compliance with the Food and Nutrition Services nutrition standards and the District Student Wellness Policy. Product Additions: 1) Item #218 – Dream Bar, \$3.11/dozen, replaces item #208 –Orange Cream Bar, \$3.11/dozen; 2) item #221 – Sour Pop \$3.30/dozen, replaces item #217 – Sour Pop, \$3.30/dozen. Attached please find the pricing information for each of the two (2) new products.
