On December 20, 2011, the Board approved a negotiated contract with Sunbelt Worksite Marketing (Sunbelt) to provide voluntary benefit administration services for Pasco School Board employees. Sunbelt has provided these services to the District for several years, and their service has been satisfactory. The first year term of the contract will expire December 31, 2012.

Ms. Mary Tillman, Director of Employee Benefits & Risk Management, has requested renewal of the contract (on file in the Purchasing Dept.) for the next term, January 1, 2013 - December 31, 2013. Please see her attached memo for further information. The contract terms and conditions were originally approved by Ms. Nancy Alfonso, Board Attorney. The District is permitted to negotiate for services of this nature under Florida Administrative Rule 6A-1.012(15).

Although there is no cost to the District for these services, we are requesting Board approval of the renewal, as the contract involves the handling of District funds.
