Introduction

R.B. Cox Elementary School is a full service school site with several health services co-located on the campus. School personnel have examined the needs of the students attending the school and identified that barriers exist to accessing mental health services. As such the leadership team at the school would like to co-locate mental health services on the school campus utilizing Full Service School Funds. This would allow students greater access to these services.

Description

R.B. Cox Elementary leadership team has reached out to BayCare Behavioral Health to provide the mental health services at the school. The agreement outlines the frequency and scope of the services to be provided by BayCare and the responsibilities of District staff to facilitate student and parent access to these services. The funding for the services provided by BayCare will come through the use of the Full Service Schools Grant.

Action Requested

We respectfully request approval of this Interagency Agreement so that this important collaboration of services can be provided to the students and families in Pasco County.

AGREEMENT FOR SERVICES AND MUTUAL COOPERATION

This agreement made and entered into this 19th day of February, 2013 and run through the 30th day of June, 2013 by and between **BAYCARE BEHAVIORAL HEALTH, INC.**, herein referred to as "**BAYCARE**" and the **DISTRICT SCHOOL BOARD OF PASCO COUNTY**, hereinafter referred to as the "**DSBPC**".

WITNESSETH:

WHEREAS, **BAYCARE** has the staff and facilities necessary for providing certain counseling and psycho-educational services in Pasco County, and

WHEREAS, the school system for which the **DSBPC** is responsible requires such services from time to time, and

WHEREAS, there is a need for cooperation and sharing of services and resources between **BAYCARE** and the **DSBPC**.

NOW THEREFORE, in consideration of the premises and the mutual covenants contained in this agreement, it is agreed by and between the parties that

BayCare will:

- a) Co-locate behavioral health services on the campus of R. B. Cox Elementary School for approximately two (2) days per week. Services will be provided during school hour.
- b) Provide individual, group and family counseling services to those individuals and families referred by school personnel or identified through the agency with parental consent. In addition, the therapist will provide screening for referral, staff and/or parent training/consultation.
- c) Comply with all consent and release of information regulatory guidelines.

The **DSBPC** will:

- a) Provide space for counseling that maintains the confidentiality of the child and/or family.
- b) Provide therapist with computer and internet access.
- c) Generate referrals with parental consent.

SHARING OF INFORMATION AND SUPPORT:

During the duration of this project, the supervisory/administrative staff of the two agencies will communicate and cooperate on matters of mutual concern.

Per Florida Statute 1012.32, the agency acknowledges that a Level 2 fingerprint screening is required of any individual who has direct contact with students while delivering services under the provision of this agreement. The agency will provide the names of specific employees who will provide services through direct contact with students and will cooperate with the School Board in meeting the requirements of the referenced statute.

CONTRACT REVIEWED

Total Disbursement to the BayCare is \$4,500.00 to be used for the following services:

- a. **Prevention/Intervention Groups** at a rate of \$80.00 dollars.
- b. **Training/Consultation Fees** at a rate of \$150.00 dollars per hour.
- c. **Screening** at a rate of \$60.00 dollars per event.

The above figures are estimates based on the goals and objectives as outlined in the project. The final costs may vary slightly depending on the completions of these objectives. **BAYCARE** shall provide a monthly accounting of services delivered and the **DSBPC** shall remit payments to **BAYCARE** accordingly.

HOLD HARMLESS: Each of the parties to this Agreement hereby agrees to indemnify and hold the other party hereto harmless from and against all damages of any nature whatsoever which are caused or materially contributed to by the negligent acts of any officer, employee, and agent or other representative of the indemnifying party and which are not caused or materially contributed to by any officer, employee, agent or other representative of the indemnified party.
