**SUBJECT:** Information for Board Regarding Florida Virtual School Contract

In accordance with Florida Statutes 1002.37 and 1002.451, and Senate Bill 1676, each district must provide eligible K-12 students with the option of participation in a virtual instruction program. On June 13, 2012, official action (attached) was taken to approve a one-year renewal of the District's Master Contract with Florida Virtual School.

Information sent to the Board in June 2012 estimated the annual cost of fees paid to Florida Virtual School at \$150,000. At the request of Ms. JoAnne Glenn, Principal of Pasco eSchool, Purchasing recently processed purchase order 13001048 to Florida Virtual School for an additional \$100,000. This purchase order is valid through June 30, 2013. We are therefore informing the Board that dollars spent under this contract are now estimated to be approximately \$250,000. As expenditures are determined by FTE, it is difficult to predict with certainty the dollar volume of expenses the District will incur under the contract in any given year. The program is funded through FTE earned by students enrolled in grades 6 – 12 by successful credit completion per half credit.

**SUBJECT:** One-year Renewal of Master Contract with Florida Virtual School/FLVS Franchise and Permission to Place Purchase Order

As you recall, in accordance with Florida Statutes 1002.37 and 1002.451 and Senate Bill 1676, beginning with the 2009-2010 school year, each district must provide eligible K-12 students with the option of participation in a virtual instruction program.

On July 6, 2010, the Board entered into a five-year contract, renewable annually by mutual consent with Florida Virtual School/FLVS. At this time, we are requesting approval to issue a Purchase Order to Florida Virtual School/FLVS Franchise for the third year of this contract. The attached contract was reviewed and approved by the Board's attorney from McClain, Alfonso, and Meeker & Dunn P.A. via email correspondence on May 8, 2012; please see the attached memo for Ms. JoAnne Glenn, Assistant Principal for Pasco eSchool, for detailed information regarding this request.

The cost, as outlined in the contract, is determined by the number of student enrollments and by the course selection. The annual cost of the fees paid is projected to be \$150,000. The program will be funded through FTE earned by students enrolled in grades 6-12 by successful credit completion per half credit.
