We are seeking permission to "piggy-back" the School Board of Sarasota County's bid #12-0103 for Gymnasium, Outdoor Bleachers, and Athletic Equipment Inspection, Maintenance and Repairs.

Under DOE Rule 6A-1.012(5), the Board may make purchases at the unit prices in contracts awarded by other governmental agencies. Considering a competitive process was conducted through the School Board of Broward County that resulted in an award for bleacher repair service and the vendors who were awarded under this contract, Lyle Bleachers, Inc. and Southeastern Surfaces & Equipment, Inc. are willing to extend the same terms and conditions of this bid to our District.

At this time, we are requesting permission to "piggy-back" the School Board of Sarasota County's bid and to place purchase orders not to exceed \$60,000 for the period of April 3, 2013 through April 2, 2014 utilizing general funds. 
