**Recommendation:** Recommend acceptance of bids as noted on attached bid tabulation sheet as lowest and best responsive, responsible bids meeting written specifications.

**Term of Contract:** This bid is for the entire District's "as needed" requirements for physical education supplies requested by the CIS Department. The percentage bid is firm and fixed for the term of the bid (catalogs may be updated in January and July of each subsequent year.) This is the first year of a three-year bid renewable annually by mutual consent of both parties. The first year contract period is July 1, 2011 through June 30, 2012.

**Notations and Exceptions:** This is a multi-award bid (up to six vendors) based on a weighted point system which considers, discount, inventory, references and on-line ordering. The award is determined by ranking the vendors highest to lowest based upon the largest number of points. The following companies are recommended for award: Greg United Sports (145 points), BSN Sports (135 points), Nasco (122.5), S & S Worldwide (115), Pyramid School Products (112 point), and Allen Sports Center (107.5 points).

Recommend rejection of bids from Alert Services, Aluminum Athletic Equipment, Lakeshore Learning, Promaxima Mfg., Riddell All American, Rogers Athletics Company, School Health Corporation and Seating Contractors for failure to meet the specification for sufficient catalog inventory of PE related items; as there were not enough items to analyze for bid evaluation purposes.

Total savings were based on past usage.

Offers from the vendors listed herein are the only offers received timely as of the specified opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
