Recommendation: This RFP was solicited for the purpose of selecting the highest-scoring firm to serve as the District's Independent Auditor. The firm selected will provide independent auditing services to the District for a period of five (5) years, beginning with an audit of the District's financial statements for fiscal year ending June 30, 2011; ending after the completion and submission of the audit report for the fiscal year ending June 30, 2015. These include, but are not limited to: Financial Audit, Review of Internal Controls, Electronic Data Processing Operations, Management Letter, Financial Reports, Single Audits, Foundation, and Reports.

Recommend acceptance of RFP per the attached tabulation from Moore Stephens Lovelace, P.A. as the highest-scoring, responsive and responsible proposer.

Term of Contract: This is a five (5)-year contract, renewable annually at the mutual agreement of the parties for fiscal year ending June 30, 2011 and ending after the completion and submission of the audit report for the fiscal year ending June 30, 2015.

Notations and Exceptions: The Evaluation Committee members noted below, independently scored the eight (8) proposals received. Four (4) firms were interviewed and independently scored by the Evaluation Committee members noted below. Carr, Riggs & Ingram, LLC. and Mauldin & Jenkins, LLC. was interviewed on July 18, 2011. Mayer Hoffman McCann P.C. and Moore Stephens Lovelace P.A. were interviewed on July 19, 2011. Scores from the RFP responses and the interviews were added to produce the final, highest-scoring proposer.

Offers from proposers listed herein are the only offers received per the specified opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.

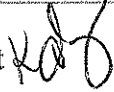
