### MEMORANDUM

RE: Bid #12-020-DR, Milk and Milk Products Third Year Renewal of Three-Year Contract Clover Creek Foods

On July 5, 2011, official action (attached) was taken to award the above-referenced bid to Clover Creek Foods. This is a five-year contract, renewable annually based upon mutual consent of both parties. Subsequently, the second year of the contract was renewed on May 15, 2012 and will expire on July 31, 2013.

Considering services have been satisfactory, Tony Cherry, Vice President, Clover Creek Foods, was contacted to verify his willingness to enter into the third year of the contract. As such, he has agreed in writing (attached), to enter into the third year of the contract with a price increase of 1.038%. This increase is based on the monthly Producer Price Indexes published by the Bureau of Statistics, U.S. Department of Labor using Industry Data Series ID: #PCU48411-48411- using the month of November, final version.

Therefore, at this time, it is my recommendation to enter into the third year of the contract with Clover Creek Foods. The third year of the contract will cover the period of August 1, 2013 through July 31, 2014.
