SUBJECT: RFP 13-012-SB River Ridge High School Yearbooks Second Year of a Three-Year Contract Walsworth

On July 31, 2012, official action (attached) was taken to award RFP 13-012-SB River Ridge High School Yearbooks to Walsworth Publishing Company. This RFP is a three-year contract, renewable annually based upon mutual consent of the parties. The first year term is set to expire on August 1, 2013.

Considering services have been satisfactory, Adam Livesay, Walsworth's Representative, was contacted to determine his willingness to enter into the second year of the agreement for the period of August 2, 2013 through August 1, 2014. As such, he has agreed in writing (attached) to do so.
