SUBJECT: Apple Computer Parts and Consortium Servicing Account Agreement

On June 20, 2006, official action was taken to approve a negotiated contract with Apple for parts for the District's in-house repair and replacement requirements. The contract allows for yearly renewals at the mutual agreement of the parties, and has been renewed every year since its inception. The current term will expire on June 30, 2013.

Considering services have been satisfactory, Craig Coile, Supervisor of Technology & Information Services, and John Simon, Director of Technology & Information Services, have asked that the contract be approved for the upcoming fiscal year. Please see their attached memo for additional information. Apple has agreed in writing to renew for the upcoming term, under existing terms and conditions. The estimated costs for the 2013-2014 school year are \$240,000, which is the same amount which was approved for the 2012-2013 school year.

We are requesting Board approval of this contract for the term July 1, 2013 – June 30, 2014. We are also requesting permission for Information Services to issue a blanket order not to exceed \$240,000 for this term. Under Florida Administrative Rule 6A-1.012(14), the District is permitted to negotiate for high-technology purchases, should it be in our best interest to do so. Purchasing will monitor expenditures under this blanket order to ensure that the threshold is not exceeded.
