## MEMORANDUM

RE: Renewal of Contract with Carone Fitness, Inc.

The attached contract renewal between Carone Fitness, Inc. (Carone) and Pasco eSchool is being forwarded to the Board for approval. Carone is an on-line health and PE curriculum licensed program appropriate for K-12 grades, that is based on state and national academic standards which provides Health Science, Physical Education, PE Variations and Supplemental Materials. The anticipated expenditure will be \$65 per semester enrollment which will be approximately \$5000 annually, and will be funded through FTE earned by successful course completion.

Ms. JoAnne Glenn, Principal for Pasco eSchool, is requesting renewal of the contract with Carone for the 2013-2014 school year. The Board approved the original contract with Carone on June 21, 2011. The original contract with Carone is on file in the Purchasing Services Department. As Ms. Glenn is satisfied with the services provided by Carone and Carone has agreed to renew the original terms and conditions of the contract (renewal attached), we are requesting approval of this contract renewal. Please see the attached memo from Ms. Glenn for additional information.

This renewal with Carone Fitness, Inc. will assist the District in meeting the requirement of Florida Statute 1002.415, 1002.37 and Senate Bill 1676. The District is permitted to enter into agreements for services of this nature under Florida Administrative Code 6A-1.012(11)(a).

Subject: Contract Renewal (Carone Fitness, Inc.)

In accordance with Florida Statute 1002.415, 1002.37 and Senate Bill 1676, beginning with the 2009-2010 school year, each school district shall provide eligible K-12 students within its boundaries the option of participating in a virtual instruction program. The program makes instruction available to students using online and distance learning technology in the nontraditional classroom.

To provide the students with a variety of learning opportunities Pasco eSchool requests approval for the renewal of a contract to continue offering virtual courses with the following provider:

- Carone Fitness, Inc.

The cost, as outlined in the contract by the provider, is based on a flat fee per semester enrollment.

The annual cost of the fees paid to this vendor is projected to be \$5,000. The program will be funded through FTE earned by students enrolled in grades K-12 by credit completion per half credit.
