SUBJECT: Contract Signature and Permission to Place Purchase Order: IBM Hardware and Maintenance Services

The Office for Technology and Information Services uses IBM iSeries hardware and operating systems software for our mainframe computers and tape library systems. The Schedule of Services in the District's negotiated Master Services Agreement with IBM (on file in the Purchasing Services Department) will expire on June 30, 2013.

Attached please find a Schedule of Services for the continuation of maintenance services for the period July 1, 2013 – June 30, 2014. Please see the attached memo from Mr. John Simon, Director of Technology and Information Services, and Mr. Ed Mutell, Supervisor of Technology and Information Services, for detailed information. The services provided by IBM have been satisfactory to date. IBM is the original equipment manufacturer for this high-technology software, and owns the copyright to the software operating system. Therefore, the District is permitted to purchase these services under Florida Administrative Rules 6A-1.012(14) and 6A-1.012(11)(b).

We are requesting Board signature on the attached agreement, and permission to place a purchase order totaling \$78,293.43, paid quarterly in arrears from general funding, for encumbrance in the next fiscal year.

I am requesting your assistance in obtaining District School Board of Pasco County approval to renew the annual agreement, valid from 7/1/2013 – 6/30/2014, for hardware maintenance and operating system software support for our mainframe computers and tape library systems. All included items in the support agreement provide for twenty-four hours a day coverage seven days a week. The cost of this agreement is \$78,293.43 and would be expensed from General Funds.

In addition to providing coverage for our production iSeries equipment, this agreement includes the same level of protection for the district's high availability computer system and disaster recovery system.

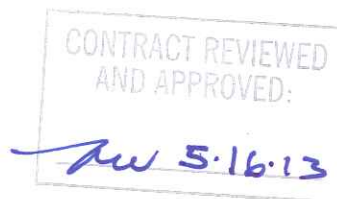
