Office Depot

The Purchasing Services Department is requesting permission to allow the District to utilize the State of Florida contract noted above for the purchase of office supplies on an as-needed basis by schools and departments throughout the District. The District will use the core optimization component of the contract which will limit the number of products available for purchase. As such, by utilizing the core optimization component, the District will take advantage of the state's \$60 million buying power which will in turn save the schools and departments money on the products they purchase.

Office Depot was contacted to determine their willingness to allow the District to utilize the state contract noted above for the period of July 1, 2013 through October 18, 2013. As such, Office Depot has agreed in writing (attached) to do so. Once the State of Florida renews this contract, a request will be sent back to the Board for approval.

Therefore, it is my recommendation to allow the District to utilize State Contract #618-000-11-1. Expenditures for this three-month period are estimated at \$300,000. The Purchasing Services Department will monitor orders to make sure this amount is not exceeded.
